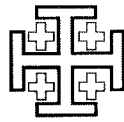

**NOTES FOR GIFT AID**

1. You must pay an amount of British income tax and/or capital gains tax equal to the tax that the charity reclaims on your donations in the tax year (currently 28p for each £1 you give) i.e. tax is paid at basic rate.
2. If you pay tax at the higher rate you can claim further tax relief on your Self- Assessment tax return.
3. You can *cancel* your declaration at any time by notifying us - if, for example, your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that the charity reclaims. Your declaration will then not apply to donations you make on or after the date you specify for cancellation.
4. If you require any further information or are unsure whether your donations qualify for Gift Aid tax relief, please contact the Secretary at the Farnham Office or alternatively you can obtain leaflet IR113 Gift Aid from your local tax office.
5. It is important that you should notify us of any change in your name or address otherwise the claim for tax that we make with the Inland Revenue would not be traceable.
